BY-LAW 98-24

A By-Law to remove roads from the County Road System and revest them in the local municipality in which they are situate.

WHEREAS by Order in Council Numbers O.C. 2398/97 and O.C. 2295/97 certain portions of Highways 62 and 517 in the Township of Bangor, Wicklow, & McClure, under the jurisdiction and control of the Ministry of Transportation were transferred to the Corporation of the County of Hastings and were vested in and under the jurisdiction and control of The Corporation of the County of Hastings.

AND WHEREAS the said highways were added to the County Road System and designated as a County Road pursuant to the Public Transportation and Highway Improvement Act, (R.S.O. 1990, c. P-50 as amended).

AND WHEREAS pursuant to Section 44(9) of the Public Transportation and Highway Improvement Act, (R.S.O. 1990, c. P-50 as amended), the County may remove a road from the County Road System thereby vesting the said road in the local municipality in which it is situate;

THEREFORE The Corporation of the County of Hastings enacts By-Law No. 98-24 as follows:


1. The Roads, as described in Order in Council Numbers O.C. 2398/97 and O.C. 2295/97 and shown on Plans P-6103-1, P-2333-37 and P-2197-35 copies of which are attached to this by-law are removed from the County Road System and vested in the Corporation of the Township of Bangor, Wicklow and McClure.
2. This By-law shall come into full force and effect on April 15th, 1998.

AND WHEREAS the said highways were added to the County Road System and designated as a County Road pursuant to the Public Transportation and Highway Improvement Act, (R.S.O. 1990, c. P-50 as amended).

AND WHEREAS pursuant to Section 44(9) of the Public Transportation and Highway Improvement Act, (R.S.O. 1990, c. P-50 as amended), the County may remove a road from the County Road System thereby vesting the said road in the local municipality in which it is situate;

THEREFORE The Corporation of the County of Hastings enacts By-Law No. 98-24 as follows:

- 1. The Roads, as described in Order in Council Numbers O.C. 2398/97 and O.C. 2295/97 and shown on Plans P-6103-1, P-2333-37 and P-2197-35 copies of which are attached to this by-law are removed from the County Road System and vested in the Corporation of the Township of Bangor, Wicklow and McClure.
- 2. This By-law shall come into full force and effect on April 15th, 1998.
